Since its birth, the MAKE Award has witnessed a progressive maturing of knowledge management, which enabled the making of many successful companies and organisations worldwide.


Due to the retirement of Mr. Rory Chase of Teleos based in London, he announced the successful completion of this Global MAKE Award in 2017.

After closing of the Award, an international working group has been formed to continue and build upon the MAKE framework to a new dimension, through the MIKE Awards which stand for the **Most Innovative Knowledge Enterprises.**

## What are the MIKE Awards?

- The Most Innovative Knowledge Enterprise (MIKE) Award builds on the original Most Admired Knowledge Enterprise (MAKE) Award as conceived by Mr. Rory Chase of Teleos in 1998.
- The name change is because we want to showcase both innovation and existing knowledge to identify and recognise those organisations which are creating shareholder and or stakeholder wealth by leveraging new innovative and existing enterprise knowledge into superior products, services, and solutions.
- The MIKE Awards are based on the original Global MAKE study, and we have substantially revised the MAKE assessment criteria. Thus, the new MIKE assessment is updated to reflect the growing dynamism of today's innovative knowledge-based enterprises.



### The purposes of the MIKE Awards are to:

- Recognise the achievement of companies and organisations on their innovation performance as a result of their effort in implementing good practices in knowledge and intellectual capital management.
- Create opportunities for companies/organisations to learn from one another to enhance their practices, and
- Provide expert feedback from the judges to applicants for their continued improvement.

## **Evaluation Process**

A panel of leading knowledge management practitioners and academics from the Australian Knowledge Management Community will be formed to select the winners of the Australian / New Zealand MIKE Awards.

Applicants are required to submit a written report as per the following MIKE Assessment Criteria in relation to your chosen Knowledge Project/Initiative/Program.



### **Guidelines for preparing your KM Stories**

#### Part A - MIKE Assessment Criteria (Sustainability Factors)

Please write narrative/stories on the efforts of your nominated Knowledge Initiative in relation to each of the 8 criteria below (with supporting data and evidence where appropriate).

	Criteria	Intellectual Capital Element (Reference Only)	Examples
1	Empowering knowledge workers for innovation	Human Capital (HC)	Recruiting, training, motivating, talent management etc.
2	Creating client and user expectations/ needs/experiences		
3	Developing internal & external networks and connectivity	Relational Capital (RC)	Open innovation, crowd sourcing strategic alliance and partnership, etc.
4	Strategizing, visioning and transformative leadership	Structural Capital (SC) - Innovation Capital	Futurizing, business models, risk taking, entrepreneurship, etc.
5	Cultivating organizational innovative culture	Structural Capital (SC) - Innovation Capital	Organizational learning, team dynamics etc.
6	Investing and delivering knowledge- based products/services/ solutions	Structural Capital (SC) - Process Capital	R&D, Idea Incubation, etc.

8	Implementing creative and virtual space to create stakeholder value	Structural Capital (SC) - Process Capital	(Future Centre, collaborative workplaces, smart office, mind lab etc.)

- Customer/client satisfaction
- Prizes/awards/honours, etc.
- Patents/ publications/new ideas etc

- A4-size, with single-lined spacing and minimum font size of 12 points
- Maximum 2 pages per criteria for Part A; maximum 1 page per measurement for Part B (including tables and figures)
- Appendices (optional such as such as company annual reports, articles, newspaper clippings etc.; maximum of 5 items)
- Start a new page for each section
- Insert page numbers in the report
- File size is limited to 20 MB
